Number/list of participants

The number of participants stated in the booking confirmation is binding.

A **reduction** of the group size from two teams (30 persons) to one team (15 persons) is possible **up to 10 working days (Mon.- Fri.)** before the visit date.

Should the number of participants exceed the previously agreed number, we reserve the right **to exclude non-registered persons** from the factory tour on the day of the visit. If the actual number of participants is below the previously agreed number, the full costs of the original planning will be charged.

You will receive a link for drawing up a list of participants. Please complete this truthfully and in full no later than three working days (Mon - Fri) before the day of the visit.

Delay in arrival, cancellation

Please arrive **punctually** at the agreed time: the tour will otherwise have to be shortened. Please give us prompt notification – **tel. +49 203 52-24425** – **in the event of emergencies or delays in arrival** on the day of your visit.

The **tour can be cancelled free of charge** at the booked conditions **up to 10 working days** (Mon. - Fri.) before the date. If you do not cancel the appointment in time or do not inform us of a reduction in the number of participants in time, we will charge you the full cost of the original planning.

Payment terms

You will **receive an invoice** sent to your specified billing address after the tour.

Safety/clothing information

Please observe the separate safety and clothing instructions.

The Visitor Center reserves the right to exclude anyone who does not observe these instructions from the plant tour.

Transfer
